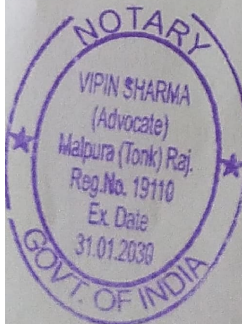

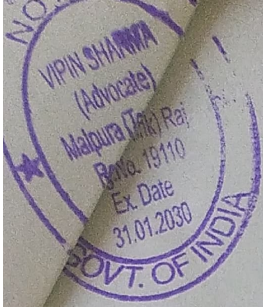

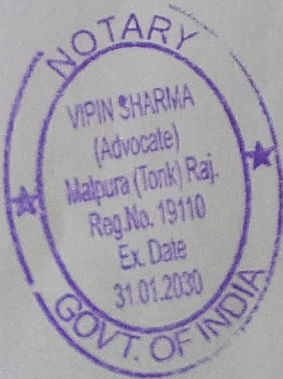
4. That the land is free from all encumbrances.

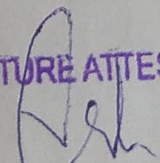
