



Course** (Chemistry, Botany, Zoology, Physics, Mathematics and Compulsory Subjects) **(with 70 seats-one section)** and **B.Com. Course** (EAFM, ABST, Business Administration and Compulsory Subjects) **(with 80 seats-one section)** for the session **2015-2016** to your college subject to fulfillment of the following conditions:

1. No admissions beyond the number of seats allotted by the University will be made. Admissions of the only eligible students will be made.
